ACEN & CCNE – REVIEW STANDARDS TO SHARE BEST PRACTICES AS A FEEDBACK MECHANISM

Bellin College – CCNE, NWTC – ACEN, Rasmussen College – ACEN & CCNE

ACEN and CCNE reference books cover a wide range of accreditation topics. Their examples can show what they are looking for, with the ultimate goal of protecting patients and students. The ACEN glossary was noted as a key tool. The same accreditation teams do not visit the sites, making the booklets very helpful.

Being in a constant state of readiness and having the right instructors with the proper credentials are important parts of this accreditation. Students need to be prepared, as employees are. If a school does not meet a specific standard, they are put on probation for a determined amount of time. Referencing GGBHA modules and key skill concepts are considered positive by the accrediting bodies. The GGBHA minutes and website can also be referenced. The accreditation reference books will be used when reviewing GGBHA modules and practices.

MAY AND MAY NOT DO LISTS – INSTRUCTOR LED CLINICALS

These lists are tailored by the individual colleges. Side one lists skills students may and may not do. Side two is specific to the level of student. Site policies supersede these lists. Members reviewed NWTC's nursing student revisions. Bellin College reps also shared their BSN program 15-month options (NR 452 & NR 372) may/may not do lists.

EPIC: PROCESS FOR STUDENT EPIC TRAINING: DEMO VS. HANDS-ON – LAURA JANSEN

Laura discussed the connectivity difficulties students have been having when trying to log into the Citrix environment. Students login through an app, as most of them are granted some degree of Epic access. The site IT process for creating logins and security for 100+ students is lengthy and now requires more steps. Aurora's Mainframe and Site Security Teams must work on this.

Laura asked if an instructor demo, with in-depth instruction, could be substituted for the hands-on experience, eliminating the creation of 100+ logins. The model for the demo format already exists. Attendees agreed the process needs to be simplified, as Epic login difficulties are universal. The process would remain the same for students going to a clinical. The Epic platform would be used at the schools.

- Over half of students are already using and well versed in Epic. Students who struggle with the training are a minority.
- Some schools and sites do not have enough computers. It was suggested to assign two students per computer, in addition to reinforcing the skills on the floor. Access should be limited.
- Whether demoing or hands-on, if the skills are not used right away, they are quickly lost.

- When Citrix gets updated, it is not updated on the schools' computers.
- Citrix will need to be on-board for any changes.
- Epic is protective in how its software is demonstrated and trained.
- Jackie Stewart shared that NWTC changed their orientation for 2nd semester so that students are oriented to their assigned hospital. The instructor is present as they all prep a patient together. Students are then assigned their patient for the next day.
 - ✓ Laura will check with their Milwaukee coordinator for any concerns in regard to implementing a demo format.
 - ✓ Have Josh, Aurora IT, available for Bellin College's March trainings, in case there are any issues.
 - ✓ Connie Buttrick will contact Laura ahead of time for Bellin College May clinical students, so she can get Josh involved.
 - ✓ Karolyn will consult with HSHS IT regarding their Epic modules. Connie Buttrick will follow-up with the HSHS IT person in regard to how they developed their modules with Epic. Connie has been in contact with the Epic rep from Madison.
 - ✓ This topic will be added to the Clinical Subcommittee's April agenda.

Milwaukee currently does not have modules and would like to use the GGBHA modules as a basis. **A GGBHA representative from each hospital was asked to work on this initiative.**

GGBHA MODULE SIGNATURES – JOANN SWANSON

JoAnn asked if an electronic signature will suffice or is a hand written signature required for the 'Confidentiality Agreement and Acknowledgement of Completion of Orientation Modules for Students and Faculty' form. What are the legalities? What is acceptable by the accrediting body? Schools keep the completed forms. A student email stating they have completed the form can serve as a legal document, in addition to signing the form.
