COVID UPDATES

COVID VACCINATIONS

Aurora Health will no longer require a COVID vaccination for teammates, physicians, APCs, vendors, students, volunteers and contractors. Therefore, no exemptions are needed.

However, the vaccine is highly recommended if you will be taking care of COVID+ patients.

FIT TESTING

- Students and instructors may care for airborne isolation patients if Fit Tested with an AAH mask.
- Annual Requirement I year renewal date required in My Clinical Exchange
- First mask of choice Mask 3M 1870+
- The instructor must be fit tested for the clinical group to care for COVID+ patients.
- The school must provide fit testing.

Merger with Atrium Health, Enterprise level – Advocate Health. Regional level, we remain Aurora Health Care.





PRACTICE CHANGES

- Badge access is required for all Medication Rooms as of
 July 31, 2023. Security will have your badge clam shell access.
- **Fall Assessment** In addition to completing a morse falls scale, RN completes the CMET within 24 hours of admission, when there is a change in condition, *or* mobility status is unknown. CMET score determines the level of assistance, and signage should be complete and visible in all med surg patient rooms.



PRACTICE CONT.

- For High Fall Risk Patients Ensure bed/chair alarms are <u>always</u> on.
- Never leave patient alone in the bathroom.

• Curos Caps – apply to all CVC, PICC, Ports (GREEN), and Dialysis Catheters (RED). They should also be applied to the end of disconnected, intermittent lines of IV tubing.



AMBULATORY UPDATES

- New Care Team Members CNA / Clinical Assistant roles becoming more prominent in primary care and specialty areas. Working alongside MAs / LPNs performing modified rooming tasks.
- New BD Push Button devices used for blood draws in both acute and ambulatory care areas.
- New primary care clinic locations: Two Rivers, WI and Marquette, MI
- Other new specialty locations coming:

COVID-19 INFORMATION

COVID-19 VACCINE MANDATE CHANGES

- As of July 1, 2023, Bellin and Gunderson Health systems have removed the COVID-19 vaccination requirement.
- The Centers for Medicare and Medicaid services (CMS) has removed its requirement for health care workers to be vaccinated against COVID-19.
- Vaccination remains an important tool in fighting COVID-19, especially for those who are at higher risk of complications from the disease.



COVID UPDATES – STUDENTS / FACULTY

WHAT IS CHANGING?

For new students / faculty:

- COVID-19 vaccination status will be obtained.
- A declination form will be signed by those who forgo the COVID-19 vaccination. The declinations will be maintained by the college.

For current students / faculty with an approved exemption:

- Daily symptom screening will no longer be required.
- Declinations will not be required as the already approved exemption will serve as the declination.



COVID UPDATES – STUDENTS / FACULTY

WHAT IS NOT CHANGING?

- Students / faculty with any symptoms related to respiratory illnesses, including COVID-19, should follow Employee Health policies <u>before</u> reporting to clinical.
- Reporting of COVID-19 vaccination status will continue to be reported for all student/faculty. The current process of sending the excel document providing the vaccination status of all students/ faculty will continue.

The survey monkey screening app will no longer be required!



FIT TESTING

Respirators (PAPR or N95) will be used when:

Patient-Suspected Risk: There is a reasonable suspected risk and/or patient presents with signs and symptoms of airborne (i.e., coughing, sneezing, etc.) medical illnesses and the employee will be within 6 feet of the patient in an enclosed space.

PAPRs with a loose-fitting hood are the preferred method of respiratory protection when caring for patients that require or are being ruled out of airborne precautions.



INFECTION PREVENTION: COVID-19 & INFLUENZA

COVID-19 VACCINATION

Recommended to stay "Up to Date" as defined by CDC.

Submit Proof of Vaccination.

Self-screen for COVID Symptoms:

- Fever or Chills
- Cough, Sore Throat, Congestion, or Runny Nose
- Shortness of Breath, Difficulty Breathing
- Fatigue or Muscle/Body Aches
- Nausea or Vomiting, Diarrhea
- New Loss of Taste or Smell

Unvaccinated Students/Faculty: Obtain current requirements or declination form from your Bellin point of contact.

INFLUENZA (FLU) VACCINATION

Required Annually (or an approved Exemption).

Submit Proof of Vaccination.

Self-screen for Flu Symptoms:

- Fever or Feeling Feverish/Chills
- Cough, Sore Throat, Runny or Stuffy Nose
- Fatigue or Muscle/Body Aches
- Headaches

Unvaccinated Students/Faculty: Mask is always required during Flu Season*.



BELLIN HEALTH REGULATORY & COMPLIANCE

INFECTION PREVENTION

- Hand Hygiene: Remove gloves after patient contact and before touching other items.
- Wear appropriate PPE.

MEDICATIONS

- Med prep needs to be at least 36 inches away from a sink.
- All medications and sharps must be secured / inaccessible to patients and visitors.

SAFETY

- Remove out of order equipment.
- Use safety devices on needles.
- Proper use of lift and transfer equipment.
- Use two patient identifiers.



POLICY UPDATES / CHANGES / REMINDERS

May 2023 implementation of the Age, Bones, Coagulation, Surgery (ABCS) injury risk assessment tool.





POLICY UPDATES / CHANGES / REMINDERS

Based on the ABCS Assessment, a nurse may implement an intervention to prevent injury.

- Floor Mats
- Hip Protectors
- Helmet





POLICY UPDATES / CHANGES / REMINDERS

FALL PREVENTION TOOLS / STRATEGIES

- Patient's white board should **NEVER** say up with 1-2; it is either up with 1 assist or 2 assist.
- Have gait belt available in room and send with patient when they leave the nursing unit, including diagnostic tests. Gait belts should be hung on the hook near the computer, in each room, when patient requires its use.
- High risk for falls indicator sign at entry to patient room.
- Yellow Armband, Yellow Slippers If patient has shuffling gait, do NOT use as grippers can be a trip hazard. They should wear their footwear that they use in their home (shoes, regular socks, etc.).
- · High risk for falls banner in the electronic medical record.
- Communicate fall risk at handoffs.





BMAT ASSESSMENT

What is the BMAT Tool?

Stands for Banner Mobility Assessment Tool.

What is the purpose of the tool?

Used by health care professionals to assess and advance patient's mobility.

Benefits

- Fewer patient falls
- Decreased caregiver injuries
- Improved confidence using lifts
- Getting patients out of bed more frequently
- Improved communication between disciplines

Other Information

- Will be rolled out in Fall of 2023.
- First one will be completed by the nurse.
- Recommendation to do a quick on each time getting a patient up.

BMAT Mobility Levels

Mobility Level Based on BMAT	Recommended Equipment	Caregiver(s)
Level 1	Total mechanical lift (EZ lift/Maxi Move) plus accessories (can be ceiling mounted/portable and lateral transfer aids	Minimum of 2
Level 2	Sit to Stand and Ambulation assist devices, & Gait belt	Sit to Stand (2 Assist) Sara Steady (1 assist)
Level 3	Standing and Raising Aid Gait belt, repositioning, walker, cane	1
Level 4	No equipment	0

You can provide more assistance than was assessed (go down a level), but should never use less assistance (go up a level) without the patient being reassessed by an RN.

- No dependent loops on Foley catheters
- Use clips
- Complete the Indwelling Foley Catheter insertion checklist for all students and return completed form to Kelly Verhasselt.



EQUIPMENT UPDATES / CHANGES / REMINDERS

CLABSI PREVENTION REMINDERS

- IV tubing should be labeled and changed per policy.
- Disinfectant caps must be applied on all access points of venous access devices.
 - Converting to Curos[™] Cap "Green is Clean".

COVID & FIT TESTING POLICIES

COVID POLICIES

- Masking may be reinstituted at specific hospitals or on specific units based on infection prevention recommendations.
- Exemption process continues as in the past. (Please note exemptions on the affiliation verification form.)

Fit Testing Policies

 N95 is still required for patients undergoing aerosol generating procedures (I hour after) and all the time for Covid positive patients.

SOCIAL DETERMINANTS OF CARE

Assessment completed on all admissions.

- Food insecurity
- Housing stability
- Intimate partner violence (interpersonal safety)
- Transportation needs
- Financial resource strain (utility difficulties)

If need is identified, Case Management works with patient to support.



PAIN ASSESSMENT / REASSESSMENT

Following pain medication administration, evaluate effectiveness by reassessing pain status, allowing for sufficient onset of medication based on route of administration.

COVID UPDATES

- Due to changes in CMS policy, we are no longer requiring proof of vaccination for COVID-19.
- Students are required to follow CDC guidelines for testing and isolation.

POSITIVE: Release from isolation criteria

After 5 full days of isolation (Day "0" symptom onset or date of test, whichever occurred first)

AND

2. Symptom improvement (lingering but mild)

AND

Fever (≤100.4°F) and diarrhea free without the use of medications, for 24 hours.

*If you are severely ill with COVID-19 or immunocompromised you should isolate for 10 full days.

FACILITY UPDATES

OB/GYN – Women's Health clinics in Western Wisconsin have been shutdown.

Laboratory Consolidation:

- Chemistries from Green Bay clinics are now being sent to St. Vincent Hospital.
- Clinics in Seymour, Washington Street, and Kewaunee transition from complex labs to CLIA waived testing.
- MLT clinical placements will be a timeframe of one month teaching the students Hematology, Urinalysis, Phlebotomy, and Specimen Processing. All others performed at Hospital.

CLINICAL SUPPORT AIDE

- Clinical role designed to support operations of the clinic.
- MA, LPN, EMT, and ADN students can transition into new roles seamlessly, usually within the same department upon certification/licensing.
- RN students can be in these roles, they just won't be guaranteed a position upon licensing.
- After 6 months, eligible for tuition reimbursement.



MEDICAL ASSISTANT ROTATIONS

- Utilize the Clinical Support Aide position for MA clinical rotations. Get paid and earn credit for rotations.
- Students would go through the Prevea employee onboarding process. The school would not need to follow the typical health requirement process.
- Tasks they can provide after successful completion of the skills checkoff:
 - Rooming patients
 - Checking vital signs
 - EKGs
 - o Etc.

BELLIN COLLEGE NURSING PROGRAMS

NURSING ASSISTANT

• NA program continues to grow with high school initiatives as well as others. Classes are being offered year-round with face-to-face and hybrid options.

BSN

- Enrollment is strong in the 3-year curriculum.
- Traditional students are moving into the junior and senior years.
- Three-year students are beginning lab and then clinical courses.



BELLIN COLLEGE NURSING PROGRAMS

GRADUATE NURSING

Bellin College is an approved college for the WI Nurse Educator Program grant dollars.

- FT and PT options available. Graduates must commit to teaching post-graduation.
- DNP students may receive \$40,000 the first year. NE students may receive \$30,000. Contact Dr. Lori Kulju for more information.

We had our first 2 graduates from the DNP program. Their projects are impactful for patient care.

- Early identification of breast cancer risk to support earlier intervention
- Utilization of online portals in CHF patients to decrease readmission

We have applied to the Higher Learning Commission for approval to start a Psychiatric Mental Health Nurse Practitioner Program.



BELLIN COLLEGE ALLIED HEALTH SCIENCES

- Student enrollment continues strong with all allied health programs.
- The Surgical Assist program will be enrolling the third cohort this fall. The first cohort will begin the surgical assisting clinical rotations this August after completing the surgical technology aspect of the curriculum.
- The Radiologic Sciences program has fully transitioned to a 3-year curriculum model. The final 4-year cohort will graduate this December.
- The Diagnostic Medical Sonography program has moved to our Van Asten Campus which now includes a 10-bed lab to support both options:
 - General Vascular Abdomen, OB/GYN, Vascular
 - Cardio-Vascular Adult echo, Peds echo, Vascular
- The Radiation Therapy program graduated the first cohort in May of 2023.



BELLIN COLLEGE PHYSICAL THERAPY

The second cohort of DPT students will begin this fall. The DPT program is primarily at the Van Asten campus.

The DScPT program continues to expand. The students and graduates have been extremely successful with publishing and working with various health care facilities to collaborate on initiatives. Topics include:

- Adherence to home exercising with musculoskeletal neck pain.
- Trials of supervised exercise for individuals with back pain.
- Relationship between pain and sleep.
- Chronic pain and opioids after spinal fusion.



COVID & FIT TESTING POLICIES

COVID POLICIES

- There is no masking requirement on campus for students, faculty, or staff. Currently follow clinical site policy on masking when at various clinical sites.
- COVID vaccination is listed as a clinical compliance item for all students and faculty. Students/Faculty can submit a medical or religious declination form; however, clinical site placement is up to the clinical site and their COVID polices.

FIT TESTING POLICIES

- We have faculty members who are FIT test certified and completes any FIT testing needed for students.
- We work with the clinical site to follow their policies for FIT testing to ensure congruency.



COVID POLICIES

- There is no masking requirement on campus for students and staff. Currently follow clinical site policy on masking when at various clinical sites.

MEDICAL ASSISTING PROGRAM

- Complete Diploma in 12 15 months (Length depends on transfer credits and course load.)
- Rasmussen pays for the 1st attempt at a credentialing exam for either the CMA (AAMA) or RMA (AMT). Students have the option to choose which exam fits them better.
- No Wait List for MA Program 8 opportunities to start per year for MA.
- Smaller class sizes provide more one-on-one instructor attention.
- Handson skills learning Students practice skills including vitals, injections, and venipunctures on each other.
- Blended education: Classes residential and online. Students attend residential lab 4 hours/wk.
